## **AGREEMENT TO CONDUCT CHARITABLE 50/50 DRAWING**

Following are the details for conducting a 50/50 raffle at Anderson Speedway:

- 1) All organizations must have prior authorization from Anderson Speedway to conduct activities on Speedway property.
- 2) All organizations must be organized as not for profit organizations, recognized by the State of Indiana, in good standing and qualified to conduct a 50/50 drawing legally.
- 3) All organizations are responsible for the proper registration with the State of Indiana and any other governmental authority to legally conduct the drawing.
- 4) **All organizations must supply their own personnel and supplies (Tickets, Table, Chairs, Change, Buckets, Signage)**
- 5) All personnel of the organization will conduct themselves in a professional manner, be properly attired and agree not to harass track patrons when selling tickets.
- 6) The raffle must be conducted in a fair manner and all revenues properly accounted for and the winner's share properly divided. Any indication of impropriety with the integrity of the drawing will result in forfeiture of all proceeds and possible legal sanctions.
- 7) All organizations will be prepared to start selling tickets when the fan gates open and will conclude when Speedway management directs.
- 8) Each organization must designate one individual (adult) to be the responsible party for the entire organization. All correspondence and problems will be this person's responsibility.
- 9) **50/50 Ticket Prices will be: \$1 for 1 Ticket, \$5 for 6 Tickets, \$10 for height (No Exceptions)**
- 10) Group size must not exceed 12 members. The group does not have to pay to enter the facility.
- 11) No alcohol beverages can be consumed during 50/50 raffle.
- 12) No smoking at the 50/50 table or by the sellers.
- 13) No outside food or beverages may be carried through main gate.
